Trae Gray to Address National and Oklahoma Forums on Land Issues

Trae Gray, founder of LandownerFirm.com and NaturalResourceMediator.com, will be a speaker at the REALTORS® Land Institute (RLI), National Land Conference (NLC) in Charlotte, NC, March 31-April 2, and he will serve as co-chair for the "Eminent Domain" conference, sponsored by CLE International,

on February 23 in Oklahoma City.

from Meinders School of Business at Oklahoma City University. He also holds a Bachelor of Science degree in agricultural sciences and natural resources from Oklahoma State University.

In 2017, Gray launched NaturalResourceMediator.com, a boutique mediation practice based on Gray's years of in-depth experience in natural resources law in Oklahoma and other states throughout the U.S. In launching this practice, Gray assumed a statewide leadership position as a mediator in the field of natural resources law. As a mediator, Trae brings over ten years of experience in natural resources law, a Master of Laws Degree in Natural Resources Law from The University of Oklahoma College of Law, and mediation and negotiation training from the Harvard Law School.
